



### Advice From Judge Migdalia Lopez

- Do not let yourself get so personally involved in your case that it affects your performance.
- When a judge rules against you, instead of getting upset and start to argue with the Court,
  1. Understand the Judge's ruling and reason for such ruling;
  2. Try to find another way to get what you want; and
  3. Take a different approach and direction.

Practicing these steps will help keep down your frustration and make you think. This is what makes you a better lawyer and advocate for your client.

- Be on time to all hearings.

- Most importantly, do not be intimidated to speak to a judge in chambers; all judges were young lawyers at one point.

## **Trial Skills Workshop CLE- “Preserving and Presenting Evidence: Principle, Problems and Pitfalls to Avoid”**



On January 26, 2011, CCYLA hosted “Preserving and Presenting Evidence: Principle, Problems and Pitfalls to Avoid,” with the Honorable Judge Rolando Olvera of the 445<sup>th</sup> Judicial District Court, Cameron County, Texas and newly appointed Presiding Judge of the 5th Administrative Judicial Region of Texas.

Judge Olvera spoke to the young lawyers about the steps to take when presenting evidence during trial and the manner in which to convince a jury and judge of their arguments. Taking questions from the audience, Judge Olvera was able to explain how to publish photos to a jury and enter evidence from foreign countries. From civil to criminal law, Judge Olvera gave members a wide range of advice from his time in private practice to his transition onto the bench. It was an honor to have Judge Olvera, the first CCYLA president, host the first Trial Skills Workshop CLE of the year.

## Lawyers Lending Hands



For a second year in a row this February, the Cameron County Young Lawyers Association participated in their *Lawyers Lending Hands* community service project. The goal of the project was to educate victims of domestic violence about their legal rights. Several volunteer lawyers visited the Cameron County Friendship of Women Shelter and Family Crisis Centers to educate the residents on what victims of domestic violence can expect when using the courts to obtain a protective order, temporary restraining order and a divorce. The attorneys were also able to answer immigration questions specifically concerning victims of domestic violence. The lawyers presented a video to the residents titled *Healing the Wounds*, answered questions from the residents as well as handed out pamphlets regarding their legal rights in both English and Spanish.

In the spirit of Valentine’s Day, CCYLA also handed out care packages to the residents. The care packages were filled with toiletries items (shampoo, lotions, toothpaste, etc.) for the residents and donations of clothes and shoes for their children. CCYLA was extremely fortunate to receive a huge donation of over 100 new children pajamas, beanies and scarves from the Brownsville Parks and Recreation Department in connection with the project. All items were donated to the shelters for their residents use. It is our hope these items can help smooth the transition of the residents into the shelters and provide some comfort during their stay.
