



Holding True To Its Mission Statement

Part of the Cameron County Young Lawyers Association's Mission Statement affirms that CCYLA will "*participate and volunteer in community service projects*." This year will be no exception as CCYLA members will fulfill their commitment to Cameron County by offering two different community service projects.

CCYLA's first project is titled "R U SAFE-Protecting Yourself In Cyberspace." The R U Safe program is designed to educate students and their parents about online dangers while also providing tools for protection. Armed with the R U SAFE video produced by the Texas Young Lawyers Association, CCYLA will visit various schools in Cameron County and present the R U Safe video and conduct a question and answer session with the students, teachers and/or parents. The topics covered in the video and presentations include cyber bullying, dangers of social networking sites, chat rooms, "sexting," and online predators. Each presentation and video is designed with the audience in mind, so elementary students will not be presented with the same in-depth video information as high school students. CCYLA will enlist the help of law enforcement personnel and the Cameron County District Attorney's office to help shed light on the dangers and consequences of such online activities. The goals of the program include, providing students with the skills necessary to protect themselves while online, teaching the students how to report suspicious online activities, informing the students of the legal consequences for inappropriate online actions and teaching parents how to implement successful safety plans for their children. This is a wonderful program for elementary, middle school, high school and even for Parent-Teacher Organizations as well.

CCYLA will also continue with its award winning project "Lawyers Lending Hands." The goal of this project is to benefit the victims of domestic violence and their children in Cameron County. During the week of Valentine's Day, CCYLA will visit the Friendship of Women and Family Crisis Center safe-houses and meeting groups. CCYLA will present the "Healing the Wounds" video, produced by the Texas Young Lawyers Association, and give presentations on various legal issues affecting victims of domestic violence, such as how to obtain a temporary restraining order, protective order and a divorce. In the spirit of Valentine's Day, CCYLA will also provide Valentine's Day care packages to the shelter residents and group meeting participants. The care packages will include toiletry items such as shampoo, conditioner, lotion, toothpaste and other items that these domestic violence victims may be without and desperately need. CCYLA will also provide toys and gift certificates to the children who are also residents at the safe-houses or who attend the group meetings. CCYLA hopes to empower the victims of domestic violence with knowledge and to comfort them with some of the necessities of daily living that they may lack.


