Remote Access and Your Law Practice By Juan Valerio Antonio



Most practitioners have a couple of computing devices at their disposal. A recurring issue is how to retrieve files located on a remote computer. Your client data files might be back at the office computer, but you'd like to view them from your laptop while traveling. By use of *remote access*, you can use one computer to access a second computer.

First, a couple of terms: there is a *client* and a *host*. The client computer requests the data and the host computer serves up the data. The client might be your laptop, your Ipad, or your smart phone. The host might be your office computer. Both the client and host computers will require their respective pieces of software to facilitate the remote access. Often, the client software is a standard web browser.

A given computer will often switch roles. For example, if you are at your home and need to access WordPerfect — a program installed only on your office computer — then your office computer acts as the host. Later, after you arrive at your office, you realize you need to update a Quicken file on your home computer. This time, your office computer acts as the client.

The simplest technique for making a file available to yourself from a second computer is to email it to yourself from the first computer. A few of the more complex techniques (with higher functionality) are presented below.

Dropbox (www.dropbox.com)

Cost: Free for 2 gigabytes of storage

Complexity of Setup: Simple

Functionality: Basic

Remarks: Dropbox installs onto your client computer(s). A file 'dropped' into the Dropbox folder on your computer is simultaneously uploaded to Dropbox's internet server. Modifications to that file, made from any of your client computers, are automatically propagated back to the original file on the internet server. Dropbox is only a place to store files. It doesn't offer software functionality (like word processing).

Remote Access and Your Law Practice cont.

Google Docs (docs.google.com)

Cost: Free for individual use; \$50 yearly for business use

Complexity of Setup: Simple Functionality: Moderate

Remarks: Google Docs is a comparatively rich productivity suite. It offers a word processor, spreadsheet application, and presentations package. The storage and functionality reside entirely on the web, so any web browser serves as the client. The business user package offers much more functionality than the individual user package—well beyond the aims of remote access.

Microsoft Windows 'Remote Desktop'

Cost: included in the price of the Windows operating system

Complexity of Setup: High

Functionality: High

Remarks: Any version of Windows beyond the "home" edition will automatically include the host software. If you have multiple home computers that are connected to a wifi access point, you'll need to configure your router to 'point to' the intended host computer. Once you've completed the admittedly onerous setup, you'll have complete access to your host computer — just as if you were sitting in front of it.

<u>LogMeIn Ignition</u> (<u>www.logmein.com</u>)

Cost: \$30 from Apple's Ipad Store Complexity of Setup: Simple

Functionality: High

Remarks: LogMeIn 'Ignition' is the variant of LogMeIn designed for the Ipad. Download the client software from the Apple App Store and the host software from the above link. The client software faithfully mimics your host computer's functionality. There's a bit of a learning curve associated with the swipe-gesture navigation of the Ipad and its correlation to the point-and-click navigation of a desktop computer.

A couple of caveats: One recurring issue is to make the mistake of overwriting a later version of a file with a prior version. You'll have to figure out your own mnemonic to guard against this (e.g., "my source file is always on my home computer", "I start my day by emailing my latest file from my home computer"). Also, you'll probably have to disregard some of the above techniques, given the constraint of what you are allowed to install on your office computer.

Dare to Dream

"Can I become a United States citizen after graduation?" "What if I've lived in the U.S. since I was 5 years old?" These were just a few of the questions Elizabeth "Liz" Valdez-Garza answered during her immigration presentation to junior and senior students at Rivera High School. In a presentation organized by the Rivera High School Parent Teacher Organization, Liz gave a crash course to Rivera High School students and their parents on the DREAM Act and how a bill becomes a law.

Liz explained that the DREAM Act (Development, Relief and Education for Alien Minors) is an legislative proposal first introduced in the Senate on 2001 and most recently on May 11, 2011, that would provide conditional permanent residency to certain illegal and deportable alien students who graduate from U.S. high schools, who are of good moral character, arrived in the U.S. legally or illegally as minors, and have been in the country continuously for at least five years prior to the bill's enactment.

"Not everyone can benefit from the Act," explained Liz, "there are certain requirements that must be met. However the students who can benefit from the DREAM Act will be able to continue working to achieve their college diploma, military service and dreams in the United States." Advocating for the passage of the Act, Liz encouraged students and their parents to write to their U.S. and State legislators to advocate in favor of the Act.
